Judy will join selected delegates from all 50 states and the District of Columbia in leading a recovery celebration march through some of the nation's most historic sites in downtown Philly.

The event is coordinated and led by Arts and Entertainment Television, NCADD, Faces and Voices of Recovery, and other sponsors that support addiction recovery efforts nationally. Each year A and E TV solicits nominations of recovering individuals that have made significant contributions to public and professional awareness, reduction of stigma, and other initiatives on behalf those having addictive disorders and those who love them.
